TAX TIPS FOR TEENS

If you have a job and earn a paycheck, you've probably noticed that each paycheck you receive has some amount of money withheld for federal income taxes, and possibly even state and local taxes. All American companies are required by law to take this money out of all employee pay.

If you're new to the job scene, here are a few things you should know about income taxes:

- Everyone who holds a paying job is required to pay taxes. And if you earn over a certain dollar amount in a given year, you will need to file an income tax form and make payment for any taxes owed. (Good news though you might qualifying for a refund!)
- ☐ You will need to understand certain paperwork and tax forms.

 Some forms and paperwork you should be familiar with are the W-4 form, paycheck stub, W-2 form, and if you work in self-employment, a Schedule C form.
- ☐ You may need to file unearned income. Unearned income is any income from investments, interest, capital gains, etc.
- ☐ If you make over a certain dollar amount in self-employment, you are required to pay self-employment taxes. Self-employment work includes babysitting, mowing lawns, walking dogs, etc.

If you've still got tax-related questions, your parents are a great resource for tax information!

CAN YOU MAKE A PLOAT?

If you've ever dropped a penny into a cup of water, you know that it sinks to the bottom right away. But did you know there's a way to actually make it float? Follow these instructions to see if you can figure out how to work against the odds. (HINT: IT'S ALL ABOUT DENSITY!)

MATERIALS:

- √ Bowl or small pail
- ✓ Water
- ✓ Penny
- ✓ Ball of clay
- ✓ Other objects that will sink or float, such as a paper clip, cork, pingpong ball, or button
- ✓ Paper towels
- ✓ Notebook

STEPS:

- 1. Hold up all of the objects and predict whether the object will sink or float.
- 2. Use your notebook to record each of your predictions.
- 3. Drop each object into the water to see if it will sink or float.
- 4. Record your findings in your notebook along with your observations about each object (size, shape, weight, etc.)
- 5. Use your collection of objects to see if you can make your penny float.

Did you figure it out? Flatten the clay ball into the shape of a boat, and then put the penny into the boat!
